These earth dog tests are held under the rules and procedures of the American Kennel Club

ELIGIBLE BREEDS: Dachshund & the following Terrier Breeds: American Hairless, Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Jagd, Lakeland, Manchester, Miniature Bull, Miniature Pinscher, Miniature Schnauzer, Norfolk, Norwich, Parson Russell, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Welsh, West Highland White, Wire Fox, and Yorkshire.

***All dogs must be at least 6 months of age to participate **AND** AKC Registered (Limited Registration is acceptable), Purebred Alternative Listing (PAL) Registered **OR** Foundation Stock Service (FSS) Registered. ***

The following tests are all offered 2 times on the same day:

Intro to Quarry (Intro): 10 feet, one 90-Degree turn. Open to dogs with any title.

Junior Earthdog (JE): 30 feet, three 90-Degree turns. Open to dogs with any title.

Senior Earthdog (SE): 30 feet, three 90-Degree turns, with false den and exit, recall. Open to dogs which have completed a JE title or higher.

Master Earthdog (ME): 30 feet, three 90-degree turns, with false entrance, den and exit, identification of entrance, honor the other working dog. Open to all dogs that have completed an SE or ME title.

Both Intro and JE classes are now open to any dog with any title to be used as a warm up.

Pre-Entry Fees (Best deal in town! Enter often!) All prices include the \$3 AKC recording fee.

\$10: Intro \$15: Junior, Senior, Master \$0: Junior Handler (any level)

\$25: Endurance Earthdog (EE)/Irondog (must fill out both SE and ME entry forms)

- Pre-Entries must be postmarked by 4/10/2021 or hand-delivered by 4/15/2021.
- Mail entries with payment to Laura Stutts (39007 NE 74th Avenue, La Center, WA 98629).
- Make checks payable to Dachshund Fanciers of Southwestern Washington (DFSW is fine.)

All Day of Show (DOS) **entries close 15 minutes prior to the start of each test.**

- Entry fees for DOS are \$10 for Intro, \$25 for Junior, Senior, Master, and \$35 for EE.
- Cash or check payment for entries.
- Event secretary will NOT have change so if paying with cash, bring exact amount.

Returned checks do not constitute a valid entry fee. Fees must be reimbursed in guaranteed funds. Checks will not be accepted. The Earthdog Secretary will add a collection fee of \$25 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis. Any awards won by dogs with invalid entries because of NSF will be rescinded unless the club is reimbursed immediately.

Confirmed entrants not present at the testing area when their number is called will be moved to the end of the class except for ME class. In the ME class, any dog not present within 5 minutes after its brace is called will be marked absent by the judge. The remaining dog in that brace will be run as or with the bye dog.

Bitches in season are not eligible to enter the test and shall not be allowed within 100 feet of any testing area during the running of any class. Pre-entry fees will be refunded.

Due to Covid-19, there will not be any food provided but we will have bottled water available. These tests are held on private property. Please honor posted signs, notices and any requests or directions from the property owners. Bring shade and shelter for you and your dogs. These tests will be run rain or shine. Please pick up after your dogs.

All dogs are to be held on short leash and under control while on the test grounds. For everyone's safety, dogs shall NOT BE LEFT UNATTENDED in exercise pens while on the grounds.

Spectators may be allowed to view the test from an area predetermined by the EVENT Judge, if they are quiet and do not distract the dogs. No dogs shall be allowed within 100 feet of the test areas.

The Dachshund Fanciers of SW Washington assumes NO responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property. It is expressly understood that exhibitors alone are responsible for their own behavior and the behavior of their dogs. Any exhibitor, handler, or spectator or dog that creates unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviors will be asked by the Event Chair to leave the Test site. In such case, no refund of any fees paid will be made.
